Minutes for April 6, 2022

1. The meeting was called to order at 6:04.
2. Sign-in and member hours were recorded on sign-in sheet.

6. 7. NEW BUSINESS: **a)** Patti Brownfield volunteered and has been appointed by Jeff Hicks (President) to be our new treasurer. **b)** Discussion on new by-laws, benefits and fees for three different tiers. Richard D. made a motion to change the name of the 3 tiers of membership from "Individual",

“Family”, and “Business” to “Bronze”, “Silver”, and “Gold” respectively and was 2nd by Patti Brownfield. All were in favor. **c)** Patty Beth made a motion to accept \$26 for Bronze, \$40 for Silver and \$75 for Gold membership fees and was 2nd by Patti Brownfield. All were in favor. Those who have already paid their fees will be required to pick the tier they would like to join and pay the added amount. **d)** Patty Beth made a motion to accept the benefits of the 3 tiers of membership and to add “ and added benefits as needed” and was 2nd by \_\_\_\_\_(? Commerce meetings would be held the first Wednesday of each month at 7:00 and the Goldfield Days Planning meetings would be held twice a month or more at 6:00 pm. Each planning committee would meet separately as needed and the Chairmen for each committee would attend the Planning meetings.
